Professor of Housing and Communities

An interdisciplinary researcher with a background in psychology and a Chartered Psychologist of the British Psychological Society. Philip has held research grants from a range of funders including the ESRC, EPSRC, European Commission, UK Government departments and devolved administrations, local authorities, housing organisations, charities and private sector organisations. Philip's work broadly aims to understand and contribute to alleviating the housing and neighbourhood inequalities experienced by members of particular marginalised communities. I have a research experience in fields as diverse as social inclusion, migration, homelessness, fuel poverty, energy efficiency and regeneration. My current research projects focus on two main issues namely migration and homelessness; in particular, how places can support the integration of poorer migrants and refugees and how homelessness can be tackled through new forms of delivery and system change. He has provided expert input to a number of bodies including the European Parliament, Council of Europe, Fundamental Rights Agency, major funders and government departments. I have had a number of external roles including as Specialist Advisor to the Parliamentary Women & Equalities Committee, a non-Executive Director of Rochdale Boroughwide Housing and have supported the UK All Party Parliamentary Groups on Migration and Gypsy, Travellers and Roma in relation to monitoring the impacts of Brexit. In

April 2019 I became Chair of the UK's Housing Studies Association and sit on the Editorial Board of Thinkhouse.

Speaker: Dr. Richard Whittle, Manchester Metropolitan University and the 'Productivity Insights Network (PIN)'

Dr Richard Whittle is an Economist at the Manchester Metropolitan University. Richard's work primarily concerns technology, behaviour and society, including online decision making, crypto currency, Artificial Intelligence and the Future of Work. His last book Algorithms, Blockchain and Cryptocurrency provided an introduction to these technologies for professionals and drew on the combination of these technologies to investigate longer term technological trends on working. His next books, one investigating online retail, Spending Without Thinking and one forecasting the future of finance, Money 2030 are both coming out in early 2021. Dr Whittle has published in Work, Employment and Society, Banking, Financial Services Policy Review, and has provided consultancy reports for the Money Advice Service, the CIPD, and AJ Bell. He produced the retail technical report for the Greater Manchester Independent Prosperity Review. In February Richard's work was presented to the European Parliament's Technology Committee and has recently been highlighted in Government Gazette. Richard is currently working on a Productivity Insights Network funded project investigating Fintech as a facilitator of socially distant economic activity.

Dr. Elke Pirgmaier, University of Leeds

Elke is a Postdoctoral Research Fellow in the Sustainability Research Institute at the University of Leeds in the [Living Well Within Limits](#) project and the [iCASP Green and Blue Infrastructure Business Cases](#) project.

Elke studies the links between capitalist dynamics and global environmental challenges, from a political economy and ecological economics perspective. Elke is keen to unveil the political implications of different economic theories and methodologies to explain barriers to sustainability transitions with a view

to supporting radical systemic change towards social and environmental justice.

Elke's PhD research aimed to strengthen theoretical and methodological links between heterodox economics and ecological economics. It is based on the recognition that tackling the interrelated nature of social-ecological phenomena from a systemic perspective is rare, i.e. there is little theorising about the environment and the economy as a whole. More theorising is needed however, as it is both important for understanding and explaining the reality of contemporary economic systems and for thinking about how future sustainable societies might look like.

Professor Andrew Brown, University of Leeds

Economics Division, Director of Research, Leeds University Business School. Dr Andrew Brown is Professor of Economics and Political Economy at Leeds University Business School. Developing a unifying approach to 'social provisioning' rooted in the political economy tradition, he has published in high quality, high impact journals on: circular economy; sustainable and resilient infrastructure and industry; value and wellbeing; financialisation; and the methodology and philosophy of interdisciplinary science.

In 2015 he was awarded the Sage prize for Innovation and/or excellence for his paper on realist methods in social science. He has led interdisciplinary economics research as PI or Co-I in numerous funded projects, (total value >£20M) bringing together economics, engineering, environmental and social sciences, and has extensive experience working with public and private sector stakeholders, for example with HM Treasury on Green Book guidelines for valuing infrastructure spend, and with DEFRA on plastics packaging waste metrics. He currently leads the [iCASP Green and Blue Infrastructure Business Cases](#), working with local, regional and national stakeholders to better value system-wide and long-term impacts of low-carbon transition. I have published numerous books, articles, chapters, and studies on banking, financial fragility, urban development, credit-market discrimination, gender and racial inequality, the Latin American and Asian financial crises, exploitation, housing finance, the subprime lending crisis, financial regulation, the Eurozone crisis, and economic policy. Some of this research has appeared in economics or political economy journals (and books), and some in geography journals (and books). Current research projects include the UK

productivity paradox; the impact and governance of financial power in the global economy; the spatial aspects of financial instability; the post-crisis challenges of economic development in lower-income areas affected by subprime lending, discrimination, and redlining; the liquidity preference/investment crisis in South Africa; the integration of macroeconomic and financial logic into economic geography; and the challenge of creating more circular, equitable, and sustainable urban and national economies.

I co-led the University's Cities research theme (2016-19)

I also serving as a research hub co-leader for the Rebuilding Macroeconomics project (ESRC Network-Plus) - <https://www.rebuildingmacroeconomics.ac.uk/>.
